Ana Rodríguez Castaño, Chairman of the Selection Board *for admission by the general free-access system to the Cuerpo Nacional Veterinario (State Veterinarians) convened by Resolution of 28 January 2021 of the Under-Secretary for Agriculture (Official State Gazette (B.O.E.) of 9 February 2021) summons the candidates who have been admitted to the selection process to the first written exam.* This one will take place on **24 April 2021**, at 9:00 a.m., at the Faculty of Veterinary Medicine of the Complutense University (Moncloa Campus), Avenida de Puerta de Hierro, 3. 28040 **Madrid (Spain)**.

The date, time and place for the beginning of the public reading of the first exercise will be published on the website of the Ministry of Agriculture, Fisheries and Food.

Applicants must come equipped with a black pen and their National Identity Document, Passport or Foreigner Identity Number (*NEI*).

In this exercise, knowledge, writing capacity, originality in the approach to the subject and the logical order in its presentation, as well as the appropriate use of language, will be assessed. A maximum grade of 17 points will be awarded, being necessary to obtain a minimum of 8.5 points to access the following exercise.

Besides, applicants must meet the requirements set out in the document: "NORMAS ESPECÍFICAS 1ER ESCRITO CNV\_OEP2019\_REV3", available on the website.

If this call is to be used as a travel document, it must be accompanied by the document "LISTA DE ASPIRANTES ADMITIDOS", available on the website.
