AUTONOMOUS COMMUNITY	CONTINENTAL AREAS
ASTURIAS	All river basins in Asturias
GALICIA	River basins of Galicia: — including the catchment areas of Eo, Sil from its sources in the province of León, Miño from its sources to the barrier of Frieira and Limia from its sources to the barrier of Das Conchas, — excluding the Támega basin.
ARAGON	The catchment area of the Ebro from its sources to the Mequinenza dam in the Community of Aragon — River Isuela from its source to the barrier of Arguis. — River Flumen from its source to the barrier of Santa María de Belsué. — River Guatzalema from its source to the barrier of Vadiello. — River Cinca from its source to the barrier of Grado. — River Ésera from its source to the barrier of Barasona. — River Noguera Ribagorçana from its source to the barrier of Santa Ana. — Matarraña River from its source to the barrier of Aguas de Pena. — River Pena from its source to the barrier of Pena. — River Guadalaviar-Turia from its source to the barrier of the Generalísimo, in the province of Valencia. — River Mijares from its source to the barrier of Arenós, in the province of Castellón. The other watercourses in the Community of Aragon are considered as safe areas.
NAVARRA	The catchment area of the Ebro from its sources to the Mequinenza dam in the Community of Aragon — River Bidasoa from its source to its mouth. — River Leizarán from its source to the barrier of Leizarán (Muga). The other watercourses in the Autonomous Community of Navarre are considered to be safe areas.
CASTILLA Y LEÓN	The catchment area of the Ebro from its sources to the Mequinenza dam in the Community of Aragon — River Duero from its source to the barrier of Aldeávila. — River Sil. — River Tiétar from its source to the barrier of Rosarito. — River Alberche from its source to the barrier of Burguillo. The other watercourses in the Autonomous Community of Castile-Leon are considered as safety zones.

CANTABRIA	The catchment area of the Ebro from its sources to the Mequinenza dam in the Community of Aragon The catchment areas of the following rivers from their sources to the sea: — Deva, Nansa, Saja-Besaya, Pas-Pisueña, Asón, Agüera. River basins: Gandarillas, Escudo, Miera and Campiazo are considered safety zones.
LA RIOJA	The catchment area of the Ebro from its sources to the Mequinenza dam, in the Community of Aragon.
CASTILLA LA MANCHA	The catchment area of the Tagus from its sources to the Estremera dam. — The catchment area of the Tajuña from its sources to the La Tajera dam.
